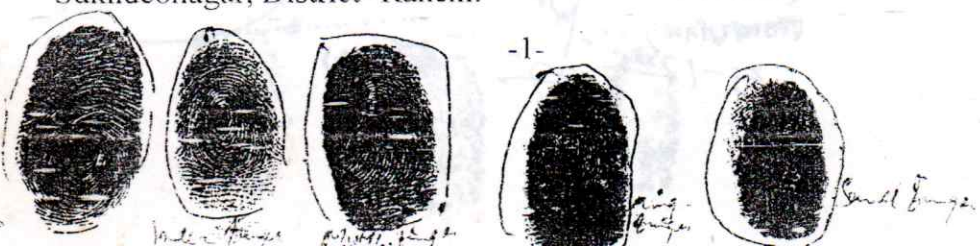

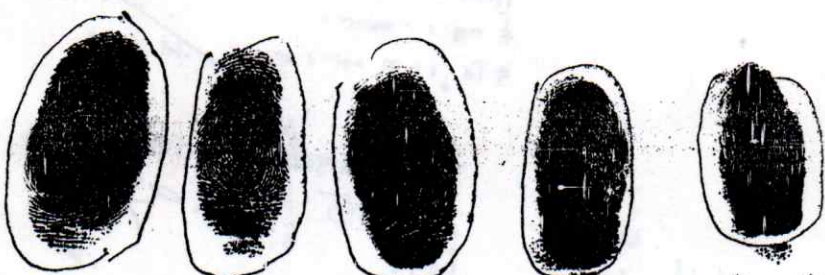

Now deed of trust declare and witnesses as follows :

- 1) This trust has been created with an initial sum of Rupees 11,000/- (Rupees Eleven Thousand only).
- 2) That the name of trust shall be KAILASH PRASAD SINGH MEMORIAL TRUST.
- 3) That the registered office of the trust shall unless otherwise decided upon by the trustees, hereinafter be located at the house of Bhim Prabhakar, New Shastri Nagar, Madhukum Ratu Road, Ranchi, P.O.- Hehal, P.S. Sukhdeo Nagar, Dist.- Ranchi.
- 4) That the managing body of the trust, i.e. the Board of Trustees shall consists of minimum two and maximum five trustees including the founder trustee (SETTLOR). The TRUSTEES have at the request of the SETTLOR agreed to act as the ten TRUSTEES and to hold and apply the said amount of Rs. 11,000/- and all the gifts, contribution, subscription and donation, etc. if any received for the purposes subject to the provisions contained in the Deed. The SETTLOR shall

be the president of the said Trust for 2 years and shall manage the trust properly in consultation with and cooperation of all the TRUSTEES and after the expiry of the said term the President shall be elected by the trustee amongst themselves for a period of 2 years. The present BOARD OF TRUSTEES shall consist of

- 1 Mr. ~~Bhim~~ Prabhakar S/o Sri Tapeswar Singh, aged about 40 years, By caste- Hindu, by occupation- Businessman, resident of New Shastri Nagar, Madhukam, Ratu Road, Ranchi, P.O.- Hehal, P.S.- Sukhdeonagar, District- Ranchi.

PRESIDENT

- 2 Pramod Kumar Singh S/o Sri Bageshwari Prasad Singh, aged about 36 years by caste- Hindu by occupation- Businessman, at present residing at New Shastri Nagar, Madhukam, Ratu Road, Ranchi, P.O.- Hchal, P.S.- Sukhdeonagar, District- Ranchi.

SECRETARY

- 3 Mr. Rajeshwari Prasad Singh, son of Late Awdhesh Prasad, Singh, aged about 62 years by caste Hindu, by occupation- Businessman, resident at Bandhu Nagar, Birsa Chowk, P.S.- Doranda, Ranchi-2

TREASURER

A New Trustee can be introduced into the BOARD OF TRUSTEES by the President in consultation with the other Trustees.

The above and TRUSTEES shall hold their office and position in their official capacity as subject to conditions mentioned in the clauses hereinafter appearing. They shall hold the said sum and sum and assets as received by TRUST FUND and manage the same for the object and purpose of the TRUST.

5) The object of the TRUST shall be

- (1) To open, establish, promote and run educational, and vocational institutions throughout India.
- (2) To establish, promote, setup, maintain and run Hospitals, Nursing Home, and Dispensaries throughout India.
- (3) To establish, promote, set up, run, maintain, assist Orphanages, widow homes, poor houses or other establishment for relief and help the poor, old and inform people.
- (4) To provide and impart efficiently and economically modern education from K.G. level to higher education including research work in every stream of education including, science, Arts, Commerce, and professional courses like Engineering, Medicine, Law, Management and other vocational courses.
- (5) To establish, maintain, assist and run boarding houses and residential institution for students and persons connected with the educational institutions.
- (6) To grant, pay or give scholarship, stipends, prizes, rewards, allowance and other financial assistance or help in cash or kind to poor and meritorious student with a view to help them in pursuing their studies in schools college, education institutions, as per other training research or educational works in India or abroad.
- (7) To realize moderate tuition fee to recamp themselves for the outlay and expenses incurred in the up keep and maintenance of the educational institution established or to be established under the deed.
- (8) To run educational as a community service and not as a business activity and to prevent commercialization of educational institutions run by it.
- (9) To generate funds for the various to heads of expenses whether recurring or non recurring.

(10) To run educational institution as per the provisions of the educational Acts and norms of affiliation.

(11) To acquire, establish, construct and run hospitals, maternity home, and dispensaries for the poor.

(6) A person of integrity and repute in the educational, professional or social field can be appointed/selected as the Trustee of the Trust.

7) The financial year of the trust shall end on 31st March, every year. The first financial year of the trust shall close on 31st march, 2008. It is incumbent upon the Board of Trustees to prepare the budget before the beginning of every financial year.

8) Power, duties and functions of the Board of Trustees.

(1) The Trustees shall from time to time after meeting the expenses of and incidental to the management of the Trust decide the particular object for which the income or corpus of the TRUST FUND or properties for the time being available shall be applied.

(i) The Trustees shall collectively be called Board of Trustees.

(ii) The Trustee in the form of board of Trustees Shall be the supreme body of the trust and shall have all power appropriate and necessary for fulfillment of any or all objects of the Trust and its efficient administration.

(iii) The board of Trustees shall cause true and accounts to be kept of all money received and spent and of all matters in respect thereof in cause of management of trust fund and properties or in relation to the carrying out of the objects and purpose of the trust as well as of all the assets credits and effects of the trust fund and properties. Proper Bank Account and books of Accounts shall be kept.

(iv) The Board of Trustees shall keep an account or accounts with any scheduled bank or banks, to operate such account or

accounts whether in debit or credit and to give all appropriate instruction to the banker or bankers concerning the operation of such account or accounts and to authorisably appropriate resolution two or more trustees to operate such account or accounts.

- (v) The Board of Trustees shall arrange for and/or authorize the signing or execution of any agreement, contract, instrument, document or any other paper, by any two of the trustees to be nominated in this behalf by the board of Trustees and to make the same effective and binding as if the said agreement, contract, instrument or document or paper or writing were signed by all the trustees.
- (vi) The board of Trustees may solicit, obtain or accept any subscription, donations, grants, gift, bequeaths, contributions in cash or in kind, from any person, firm, company, corporation, associations, institutions whether in India or abroad, state or Central government for the furtherance of the objects of the trust or for any one or more of them upon such terms and conditions as they may, in their absolute discretion think fit and which are not inconsistent with the objects of the trust.
- (vii) The boards of Trustees shall have the right to borrow and take loan from the bank and other financial institution government and non-governmental organizations and individuals. The Trust shall also have the right to borrow, raise funds for its activities from the individual and the people.
- (viii) The Board of Trustees shall have right to acquire property both, movable and immovable, acquire and posses and maintain assets, securities bonds, stocks and shares.
- (ix) The board of Trustees shall have the right to spend any portion of the trust income/fund purchasing any land or construction

any building or buildings for the purpose of carrying out, promoting and/or executing any or all of the objects of the trust.

- (x) The board of Trustees shall be entitled at their discretion from time to time to start, discontinue, abolish and re-start and charity or institution, to impose any condition or conditions to any subscription or donation made by them and to earmark any portion of the trust property or income/fund for any particular object or objects.
- (xi) The board of Trustees may reimburse themselves and pay and discharge out of the Trust Income fund all expenses incurred by them in or about the execution of the trust, or any or their duties under these presents including traveling expenses, but will not be entitled to any remuneration.
- (xii) The Board of Trustees may establish their office at such place or places and may change such places from time to time as they may think fit and proper.
- (xiii) The board of Trustees may appoint secretaries, Manager, lawyer, Auditor or other employees for carrying out the purposes of the trust and the remuneration to be paid to such employee shall be decided by the Board of Trustees.
- (xiv) The board of Trustees shall be entitled to sue in the name of the trust and may similarly be sued in the name of the trust.
- (xv) The board of Trustees shall have the right to terminate the employment of any such employee and where it thinks fit and proper.
- (xvi) The Board of Trustees shall by majority decision have the power to select and appoint new trustee, but not so as to exceed the maximum number.
- (xvii) The board of Trustees may from time to time frame schemes and rules and regulations to carry out the objects of the trust

and for managing the affairs of the trust and otherwise for giving effect to the objects and purpose of the trust and to vary the same from time to time as the trustees may in their discretion deem fit and proper by a majority decision.

9. All the Trustees unless they voluntarily resign or otherwise decide, shall continue to be the trustee during the terms of their natural lives.
10. A person shall cease to be a trustee in any of the following events:
 - (i) If he dies, or
 - (ii) If he becomes insane or otherwise became incapable to act, or
 - (iii) If he resign from office.
11. The number of trustees shall be not less than two and not more than five.
12. The board of Trustees for the time being shall elect from amongst them one president, secretary and one treasurer.
13. POWER AND DUTIES AND FUNCTIONS OF THE PRESIDENT :
 - (i) The president on behalf of the Trustees and Trust shall be over all in charge of the Trust and its activities. He shall act on the advice of majority of trustees
 - (ii) The president shall supervise the day to day activities of the trust on the advice of secretary.
 - (iii) The president shall have a contingency fund as may be decided by the board of trustees with him and over which he shall have the power to disburse for the proper and smooth functioning of the Trust. He shall open and operate a separate bank account in any scheduled bank for the said purpose. However any such disbursement made shall be placed in the next meeting of the board of Trustees and proper accounting of all the disbursement made shall be maintained by the president.

- (iv) The president shall keep the custody of the seal of the Trust and wherein necessary fix or cause to fix the same on all documents and deeds to be executed on behalf of the trust.
 - ✓ (v) The president shall convene the meeting of the board of trustees and shall also prepare the Agenda of the meeting on the advice of secretary.
 - ✓ (vi) In the absence of the president Secretary trustee shall preside over the meeting of the trust board.
 - ✓ (vii) All meetings of the trust board shall be held at such place and at such time as the president of the trust on the advice of secretary shall decide from time to time.
14. The Treasurer shall be the custodian of the fund of the trust and shall be responsible to hold and maintain the accounts of the trust according to the Financial year i.e. 1st April to 31st march as per the English calendar.
15. Two trustees at a meeting shall form a quorum for any meeting of the trust board.
16. Notice of the meeting of the board of trustees and all communications may be sent to the trustees and at their addresses registered for the time being in the records of the trust.
17. The minutes of the proceeding of every meeting of the Trust Board shall be entered in a book to be kept for that purposes and signed by the President of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting.
18. All proceeding and questions and matters arising at the meeting of the board of Trustees shall be decided by a majority of votes and in case of equality of votes the president shall have a second or casting votes.

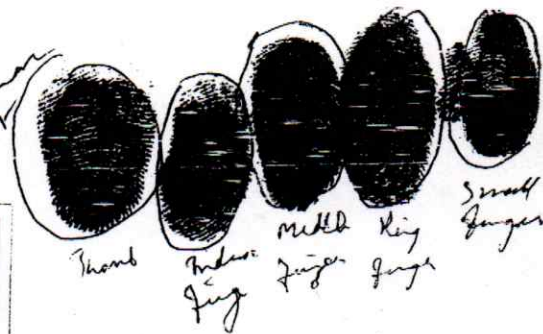

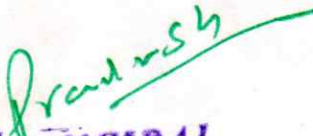

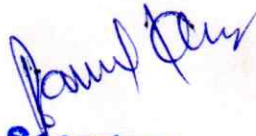
